I also lend unto ^{her} during her natural life two negroes named Rose Jim also one black horse three Cows & Calves all the Sheep I am possessed of two beds & furniture, all my Kitchen furniture & after her death the Utters I lent to her during her life my will & Desire is they shall be Equally divided ~~between~~ Increase between my three Children Henry, Matthew & Elizabeth Eum to they their Heires & Assigns for ever — My will and desire is my negroes shall be held out as ~~above~~ not before lent untill my Eldest Son comes to the age of twenty years or marries and then for them with their increase to be Equally divided ~~between~~ my three Children Harry Matthew & Elizabeth Eum each Share & Share alike to them their Heires & Assigns for ever — My will & desire is that my Executors hear after men tioned shall as soon as convenient after my death break out my mill untill my Eldest Son come to the age of twenty one years or marries and the money arising from the Rents be Equally divided ~~between~~ my three ^{children} when my Eldest Son comes to the age of twenty one years or marries to them their Heires & Assigns for ever — I Give and bequeath unto my two Sons Henry & Matthew Eum my Mill with all its Conveniences

I give & bequeath unto my two sons Henry & Matthew ^{each}
all my Lands I do posse of to be equally divided betwixt
them their lives & affigues for ever —

My will and desire is that my Executors hereafter
mentioned as soon as convenient after my death
sell all my Stock of hogs Cattle & Horses & household
furniture I have not before left also my working
tools and every other Article I do possess and
money arising to be equally divided betwixt my three Children
when my Eldest son comes to the age of twenty one
years or marries to them their lives and affigues
for ever — My will and desire is that after my
just debts and funeral expences is paid that all the
money I do in possession of also all the money due
by bonds notes accounts or otherwise should be
equally divided betwixt my three Children to them
their Heirs and affigues for ever

Lastly I nominate and appoint my friends James
Pam & Sam Phillips my sole Executors to this my
last will and Testament in witness whereof I have
hereunto set my hand and affixed my seal this 17th

September 1789
